#### 1. Consent

#### 2. Rights Granted

I grant the Employer and its affiliates, subsidiaries, and authorised third-party contractors a non-exclusive, royalty-free, worldwide, perpetual, transferable, and sublicensable licence to use, reproduce, edit, modify, enhance, publish, distribute and otherwise exploit My Appearance in any media now known or developed in the future.

The Employer agrees not to use My Appearance in any way that is misleading, defamatory, unlawful, or damaging to my reputation, and will ensure that all use is consistent with the norms and standards of the Employer's industry.

I waive any moral rights I may have in relation to such use, including the right to be identified as the author or to object to derogatory treatment, subject to the above limitations.

This consent will continue after the termination of my employment.



## 3. Ownership

All recordings and materials incorporating My Appearance will remain the property of the Employer.

### 4. Compensation

I acknowledge that I will not receive any payment or compensation for the use of My Appearance in promotional materials, beyond the remuneration provided to me under my employment contract.

## 6. Acknowledgement

I have read and understood this Agreement. I understand that I am not required to give consent and that my decision will not affect my employment.

#### 7. General Provisions

Employee Signature

- (a) Entire Agreement: This Agreement constitutes the entire agreement between the parties regarding its subject matter and supersedes all prior understandings or communications.
- (b) Governing Law and Dispute Resolution: This Agreement is governed by the laws of [Insert State/Territory], Australia. Any dispute arising under or in connection with this Agreement shall first be attempted to be resolved through good faith negotiations between the parties. If such negotiations fail, the parties submit to the non-exclusive jurisdiction of the courts of that jurisdiction.

- (d) Amendment: This Agreement may only be amended in writing signed by both parties.
- (e) Counterparts: This Agreement may be executed in counterparts, each of which will be deemed an original, and all of which together constitute one and the same instrument.
